Receive the Highest Rates Yet with Oral Health Connections



Great news from Oral Health Connections! The pilot has been extended through 2023. Not only that, but certified providers can now receive the highest reimbursement rates to date for treating Apple Health (Medicaid) insured pregnant people and people with diabetes

Oral Health Connections (OHC) is a system of care that connects Apple Health (Medicaid) insured people with diabetes age 21 and older (including dual eligible clients) and pregnant people age 16 and older with dental providers trained and certified to treat them. OHC providers receive enhanced fees for certain procedures, while local partners provide support to help patients make and keep appointments.

Now in its third year, OHC is actively connecting patients in Spokane, Cowlitz, and Thurston counties.

Why Oral Health Connections?

As a certified OHC provider, you can expect to receive:

- Free CDE training on how to deliver safe, effective dental treatment to pregnant people and people with diabetes and understand the relationship between oral health, pregnancy, and diabetes.
- > **Enhanced reimbursement rates** for certain procedures when treating eligible patients. FQHCs receive 3 additional encounters per 12-month period.
- Patient referrals through DentistLink, a free nonprofit referral service, funded by Arcora Foundation.
- > **Technical support** implementing OHC in your dental practice and billing for OHC services.

Both new and existing patients who are OHC eligible receive enhanced benefits once providers are certified, and OHC providers can bill for OHC enhanced fees for these patients.
